
The General Data Protection Regulation

Key principles of the GDPR

The General Data Protection Regulation (the GDPR^[16 p.9]) (Regulation (EU) 2016/679 on the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC), was published in the Official Journal of the EU on 4 May 2016. Its provisions became directly applicable and fully enforceable in all EU Member States on 25 May 2018.

Article 5.1 of the GDPR outlines the following seven key principles:


Article No.	Principle	Explanation
Article 5(1)(a) of the GDPR	II awiiiinacc tairnacc and trancharancv	Processing must be lawful, fair, and transparent to the data subject.




Article 5(1)(b) of the GDPR	Purpose limitation	You must process data for the legitimate purposes specified explicitly to the data subject when you collected it.
Article 5(1)(c) of the GDPR	Data minimisation	You should collect and process only as much data as absolutely necessary for the purposes specified.
Article 5(1)(d) of the GDPR	Accuracy	You must keep personal data accurate and up to date.
Article 5(1)(e) of the GDPR	Storage limitation	You may only store personal data for as long as necessary for the specified purpose.
Article 5(1)(f) of the GDPR	Integrity and confidentiality	Processing must be done in such a way as to ensure appropriate security, integrity, and confidentiality (e. g., by using encryption).
Article 5(1)(g) of the GDPR	Accountability	The data controller is responsible for being able to demonstrate GDPR compliance with all of these principles.




